

The Paramedic psychomotor examination consists of ten skills presented in a scenario-type format. The Advanced EMT psychomotor examination consists of nine skills presented in a scenario-type format.

### **Important Info for NREMT Candidates:**

1. You are required to bring a copy of your PATT with you to the examination site.
2. Payment is due at the time of Registration. Exact cash at the site is acceptable for Retests Only.
3. You are required to bring a government-issued form of identification with you to the examination site.
4. Snacks and water will be provided. Lunch may be served if testing exceeds four hours. It is also recommended that you bring snacks and drinks if you have any specific dietary needs. Electricity is available. Microwave available at some sites. Please call to confirm.
5. You will NOT be allowed to leave the facility for any reason once the testing process has begun. If you leave, you cannot return, and your attempt is a failure.
6. Candidates may cancel their reservation until 14 days prior to the date. After rosters are submitted, no refunds are available. Candidates who do not show up for the examination will be unable to reschedule for another examination until the original examination has been processed. Candidates can only register for one examination at a time. Failure to attend an examination does not count as an attempt.
7. Study materials are actively discouraged at the test site. Please bring a book, puzzle book, deck of cards, coloring/drawing materials, etc. so you can relax. Materials are also provided in the processing room for candidate use.
8. Skills sheets are available for candidates preparing for a Retest Only. No tutoring or coaching is allowed on site.

### **Paramedic Psychomotor Exam Retest:**

Candidates are allowed two full attempts to pass the psychomotor examination (one full attempt is defined as completing all six skills and two retesting opportunities if so entitled).

**Same-day retesting is at the discretion of the NREMT Representative. Same-day retesting is not guaranteed.**

Candidates are eligible to retest three or fewer skills when taking a full attempt at the psychomotor examination. Candidates are eligible for two retest attempts of the three or fewer skills failed. If offered, only one retest attempt may be completed on the same day. Failure of any skill on the second retest attempt constitutes complete failure of the entire psychomotor examination. Candidates who fail four or more skills have failed the entire psychomotor examination.

Candidates who fail a full attempt or any portion of a second retest attempt must submit official documentation of remedial training overall skills before starting the next full attempt of the psychomotor examination and re-examining over all six skills, provided all other requirements for National Certification are fulfilled. This official documentation must be signed by a Paramedic Training Officer, Program Director, or Medical Director that verifies remedial training overall skills have occurred since the last unsuccessful attempt and the candidate has demonstrated competence in all skills. Should a candidate fail the second full and final attempt of the psychomotor examination, the candidate must complete a new, state-approved, and CAAHEP-accredited Paramedic Education Program.

Passed portions of the psychomotor examination remain valid for 24 months.

### **Psychomotor Assessment Only**

Candidates may choose to take the psychomotor examination as an assessment. Assessment candidates are not eligible for National Registry certification, but may require proof of successful completion of a National Registry examination for the following reasons:

- State EMS licensure
- Instructor status/licensure
- Remediation
- Other reasons at the request of State EMS office

Psychomotor assessment candidates will NOT receive a PATT number. Instead, they will be handwritten onto the roster on examination day. Candidates must register online and pay the \$350 fee. The Assessment Candidate's examination results will be returned to the National Registry and then forwarded to the State EMS office upon their request.

### **Practice Assessment Only**

Practice Candidates may choose to take the psychomotor examination as a practice attempt prior to the actual attempt. Practice is available on the day before the test by appointment only.

Registration is required at least 2 weeks in advance. Practice attempt fee varies and is non-refundable. Practice Candidates will be coached and debriefed on their attempt by authorized NREMT proctors to facilitate success on test day. Purchase here: [www.PBCPR.com](http://www.PBCPR.com)
